By submitting the above entitled Script to Flying A Studios, Inc (FAS), the Author(s) (hereinafter collectively "Author") of the Script, in consideration for the review of the Script by FAS for possible production of the Script by FAS or its assigns, agree as follows:

1. Scripts will not be returned and there will be no acknowledgment by FAS as to the receipt of a script by the Author, unless FAS, at its sole discretion, contacts the Author.
2. Illegible, unsigned, incomplete and undated Script Submission Agreements ("Agreement") will result in the Script not being reviewed by FAS.
- 3 Author acknowledges that no oral or written representations of any kind, except as contained in this Agreement, have been made by FAS to Author and that this Agreement is the sole document governing the submission of the Script. Author acknowledges that there is no fiduciary or prior business relationship between Author and FAS.
4. FAS is under no obligation to produce any submitted Script nor review any Script within any specific time frame.
5. Author understands that FAS receives many scripts and that these scripts may be similar to Author's script in many aspects, including but not limited to, plot line, characters, time period and pacing and that FAS is a producer, and is not in the script writing business. Author agrees that in the event FAS produces a work that is similar to Author's, Author will hold harmless and not institute suit against FAS, or any other company associated with the production and distribution of the script, nor be entitled to any injunctive relief of any kind against FAS, or any other company associated with the production and distribution of the script. This Paragraph five in no way limits the right of the Author to institute litigation against a third party infringer of the Script.
6. This is a legally binding contract between you and FAS. The Author acknowledges that he or she has the right and obligation to have his or her attorney review this Agreement.
7. This Agreement shall be governed by the laws of the State of California and Author agrees to submit to the personal jurisdiction and venue of a court of competent jurisdiction located in the County of Los Angeles, State of California. No action shall be brought in any other court.
